On the First Date of Sale:

1. **Registration**
登記

All persons or companies (if the registrant is a company, then any one of its directors) must complete and return the Purchase Form distributed on the First Date of Sale and submit the following **personally** to 9/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong (“the Sales Office”) from 11:00 a.m. to 12:00 noon on the First Date of Sale (“Attendance Registration Period”):-

所有個人或公司（如登記人為公司，則該公司任何一位董事）須於出售首日上午十一時至中午十二時（下稱「登記人報到時段」）之內親臨香港九龍尖沙咀海港城港威大廈第二座 9 樓（下稱「售樓處」）即場填妥於出售首日所派發的購樓表並遞交 :-

(a) relevant cashier order(s). The number of cashier order(s) shall be equal to the number of specified residential property(ies) which the registrant intends to select as indicated in the Purchase Form. Each cashier order shall be in the amount of HK\$100,000 and made payable to “BAKER & MCKENZIE”, Please bring along blank cheque(s) for payment of balance of preliminary deposit(s); and

(b) copy(ies) of the H.K.I.D. Card(s) or Passport(s) (as the case may be) of the registrant (if the registrant is/are individual(s)) or copy of the valid Business Registration Certificate, Certificate of Incorporation and the latest Annual Return of the registrant and the H.K.I.D. Card(s) or Passport(s) (as the case may be) of the director(s) of the registrant (if the registrant is a company).

(c) The registrants will be divided into two groups. Those registrants who indicate an intention to select more than one specified residential property will be placed in Group A. Those registrants who indicate an intention to select only one specified residential property will be placed in Group B.

2. **Selection of specified residential properties**
揀選指明住宅物業

(a) **Procedures for Group A and Group A Unit Selection**
A 組別的程序及 A 組別揀樓

i) Group A Unit Selection will take place after the Attendance Registration Period on the First Date of Sale. Each Group A registrant will be asked to indicate which specified residential properties that registrant intends to select. A Group A registrant who indicates to select any specified residential property which any other Group A registrant also indicates to select will be referred to as “Group A Competing Registrant”. Each Group A registrant who is not a Group A Competing Registrant will proceed to select the specified residential properties which that Group A registrant indicated to select. The priority of the selection of specified residential properties among all Group A Competing Registrants will be determined by way of balloting.

A 組別揀樓將於出售首日登記人報到時段後進行。A 組別登記人將被邀表明意欲揀選哪幾個指明住宅物業。其所表明意欲揀選的任何指明住宅物業與任何另一名 A 組別登記人所表明意欲揀選的指明住宅物業相同的 A 組別登記人稱為「A 組別競購登記人」。每一並非 A 組別競購登記人之 A 組別登記人揀選其所表明意欲揀選的指明住宅物業。所有 A 組別競購登記人之間揀選指明住宅物業的先後次序以抽籤決定。

- ii) Each Group A registrant must select **at least two (2) and no more than four (4) specified residential properties** and at most one (1) one-bedroom specified residential property can be selected by each Group A registrant. Where it is the turn of a Group A registrant to select specified residential properties that Group A registrant fails to make such a selection (whether or not because of there remaining a sufficient number of specified residential properties for fulfilling such requirement), such Group A registrant will cease to be eligible for selection of any specified residential properties in the Group A Unit Selection.

每個 A 組別登記人須揀選最少 2 個及最多 4 個指明住宅物業。每個 A 組別登記人只可揀選最多 1 個一房的指明住宅物業。如輪到 A 組別登記人揀選指明住宅物業時因任何原因未能作出如此揀選（不論是否因為剩下可供揀選的指明住宅物業數目不足以符合該要求），則該 A 組別登記人將被取消 A 組別揀樓時段內揀選任何指明住宅物業之資格。

- iii) (If the Group A registrant is/are individual(s)) The purchaser of at least one such selected specified residential property shall be that Group A individual registrant with or without one or more relative(s) of that Group A individual registrant, and the purchaser of each other such selected specified residential property(ies) shall be: (1) that Group A individual registrant (or any one or more persons comprising that Group A individual registrant) with or without one or more relative(s) of that Group A individual registrant; or (2) one or more relative(s) of that Group A individual registrant.

(如 A 組別登記人為個人) 最少一個如此揀選指明住宅物業之買方須為該 A 組別個人登記人，連同或不連同該 A 組別個人登記人之一名或多名親屬；其他如此揀選指明住宅物業之買方須為：(1) 該 A 組別個人登記人（或組成該 A 組別個人登記人之一名或多名人士），連同或不連同該 A 組別個人登記人之一名或多名親屬；或 (2) 該 A 組別個人登記人之一名或多名親屬。

- iv) (If the Group A registrant is a company) The purchaser of at least one such selected specified residential property shall be that Group A company registrant, and the purchaser of each other such selected specified residential property(ies) shall be: (1) that Group A company registrant; or (2) a company which is incorporated in Hong Kong and any one director of which must be the same person as any one director of that Group A company registrant.

(如 A 組別登記人為公司) 最少一個如此揀選指明住宅物業之買方須為該 A 組別公司登記人；其他如此揀選指明住宅物業之買方須為：(1) 該 A 組別公司登記人；或 (2) 一間香港註冊成立及其任何一名董事須與該 A 組別公司登記人的任何一名董事為同一人的公司。

- v) If a Group A registrant has made a selection of specified residential properties as aforesaid, but for whatever reason the purchaser(s) concerned is/are unable or refuse to sign the Preliminary Agreement for Sale and Purchase of each of the selected specified residential properties, it will be deemed that the said Group A registrant has given up the right to select and purchase any specified residential properties in Group A Unit Selection. In such event, such Group A registrant will not be eligible to select any specified residential properties in Group A Unit Selection on the First Date of Sale and any specified residential properties already selected by that Group A registrant may not be purchased.

(b) Procedures for Group B and Group B Unit Selection

B 組別的程序及 B 組別揀樓

- i) Group B Unit Selection will take place after Group A Unit Selection. The priority of the selection of specified residential properties among all Group B registrants will be determined by way of balloting.

B 組別揀樓將於 A 組別揀樓完成後進行。所有 B 組別登記人之間揀選指明住宅物業的先後次序以抽籤決定。

- ii) Each Group B registrant (regardless of individual or company) can only select **at most one (1) specified residential property**. The purchaser of the selected specified residential property shall be that Group B registrant with or without one or more close relative(s) of that Group B registrant. If a Group B registrant has made a selection of specified residential property as aforesaid, but for whatever reason the purchaser(s) concerned is/are unable or refuse to sign the Preliminary Agreement for Sale and Purchase of the selected specified residential property, it will be deemed that the said Group B

registrant has given up the right to select and purchase any specified residential property in Group B Unit Selection. In such event, such Group B registrant will not be eligible to select any specified residential property in Group B Unit Selection on the First Date of Sale and the specified residential properties already selected by that Group B registrant may not be purchased.

每個 B 組別登記人 (不論是個人或公司) 只可揀選最多一個指明住宅物業。如此揀選的指明住宅物業之買方須為該 B 組別登記人，連同或不連同該 B 組別登記人之一名或多名直系親屬。如 B 組別登記人已按上文揀選指明住宅物業但因任何理由相關買方未能或拒絕簽署該個已揀選之指明住宅物業的臨時買賣合約，該 B 組別登記人將被視作放棄在 B 組別揀樓時段內揀選及購買任何指明住宅物業的權利。在這種情況下，該 B 組別登記人將不能於出售首日 B 組別揀樓時段內揀選任何指明住宅物業，而其已揀選的指明住宅物業將不可購入。

3. A “relative” of a registrant shall mean a spouse, parent, child, parent-in-law, child-in-law, grandparent, grandchild, sibling, parent’s sibling, nephew or niece of the registrant or any person comprising the registrant provided that the registrant must provide the relevant supporting documents to the satisfaction of the Vendor to prove the relationship(s). The Vendor’s determination as to whether there is such a relationship shall be final.

4. A “close relative” of a registrant shall mean a spouse, parent, child, grandparent, grandchild or sibling of the registrant or any person comprising the registrant provided that the registrant must provide the relevant supporting documents to the satisfaction of the Vendor to prove the relationship(s). The Vendor’s determination as to whether there is such a relationship shall be final.

5. The Vendor reserves its right to adjust the time of selection of specified residential properties in accordance with the progress of confirmation and verification of identities of registrants or the carrying out of other procedures.

Details will be announced on the website of the Development and registrants will not be separately notified of the same.

All persons interested in purchasing the specified residential properties arriving at the Sales Office at or before 3:00 p.m. on the First Date of Sale will be deemed to arrive at the Sales Office at the same time at 3:00 p.m. and the priority of the selection of specified residential properties among all such persons will be determined by way of balloting.

8. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any interested person.
